

## Introduction to business in the UK



In the United Kingdom, anyone of any nationality can start a business. You do not need to have a residential status or to be living in the country.

Starting a business is really exciting, but requires a large amount of time and energy, therefore picking a business that you are passionate about is key!



### Have a good business idea

Having an idea is the beginning of the journey. You will need to assess your idea, research the market and establish an initial business plan.

#### Start by questioning yourself about your idea:

- What kind of suppliers will you need?
- How much will it cost you to launch your business?
- Will you need staff?
- Who are your customers?
- Can you use your existing skills and experience?
- Is there a gap in the market for your business?

Avoid an overly optimistic business plan by asking family and friends to review it.



Think about what you want your business to be called. Try to make your business name unforgettable, unique and a name that reflects your business. If you are setting up a limited company, remember to conduct a business name search to ensure the name you have for your company isn't already being used.


### Decide your company structure

#### Sole trader

Under this business model, one person owns and runs the entire company. The owner is entitled to all profits and also liable for any debts or damages. This is a popular option for independent freelancers, plumbers, hairdressers, gardeners etc.

A sole trader cannot have partners, directors or shareholders and you only need to register as a sole trader if you have earned over £1,000 in the business tax year.

If you earn over £1,000 in a tax year, you are required to register your business with HMRC. Every year you must fill out a HMRC self-assessment form which will determine how much tax you pay.



Decide your company structure



#### **Limited company**

This type of business is separated from its owner meaning that the owner is only liable for the amount they have invested in the business. Most companies in the UK are set up like this e.g., hair salons, cake shops, and construction businesses. This type of business must register with Companies House and file annual financial reports.

#### **Partnership**

This type of business is where owners are business partners, meaning they share profits, debts and expenses. This type of business is commonly used by dentists, law and accounting firms, and vets. A partner doesn't need to be a person it could be a limited company partnering with another limited company.

## Write a business plan and complete your financial forecast

#### Always remember **SWOT**:

Strengths Weaknesses

Opportunities Threats

This will help you answer difficult questions about your business.

You will need both a business plan and a financial forecast to apply for any type of funding. Make sure you accurately work out how much money you will need to start your business. There are different funding opportunities such as grants and loans for new businesses.



If possible, find a business mentor



Business mentors can help you develop your ideas for growth by sharing their skills, expertise, experience, and contacts. At ACH, we can connect you with fellow business owners to support you on your business journey.

### Test your product/ service

Just because there is a gap in the market for a particular product or service, it doesn't automatically mean that there is a demand for it. Test trading allows you to gather information about the quality of your business idea, for example:

- Selling at a local Christmas market
- Giving away free food and drink samples
- Selling products on eBay

Set up a business bank account and register your business



Having a business bank account is highly recommended. It will help you to keep track of your income and outgoings, separate your personal finance from your business's and look professional.

You will need to register your business on the gov website.

### Market your business

Your chance to get creative!

Consider how you want to brand your business and how you will market it to customers.

Do your competitor research and think about setting up social media accounts, a website, building an email list you can send emails to, any local events you could advertise your business at and also the materials needed to do this, for example, posters and flyers.



**Business insurance** 

Do your research on the type of business insurance you'll need. Your business insurance will be dependent on the type of business but is very important to protect your business. Public Liability Insurance is what most businesses will have (or product liability, if it is a product you are selling).



## Officially launch your business (optional)

This is arguably the most exciting step – you may decide to invite friends and family to celebrate with you.


This is the perfect opportunity to give out free samples or tell people about your new business.

## Important things to consider

#### **Taxes**

The type of taxes you pay depends on your business structure and income. It is important to be aware of the different types of business tax.

Keep a record of your finances to be able to complete your self-assessment and store your business records somewhere safe; you are required to keep them for several years.

## Important things to consider

#### Licences

Check the <u>gov website</u> to see if you need a business licence. You might need a license for some business activities, for example, selling food.

#### **Training**

Some business types require specific training. Consider if you need to complete any training/courses in order to run your business efficiently.


