Support and Information from the UK Government

The national government has provided information on the support packages that are available on its website. Below are links to some of the support that is currently available. Please note that this is subject to change as the situation evolves.

The Bounce Back Loan Scheme

The Bounce Back Loan scheme helps small and medium-sized businesses to borrow between £2,000 and £50,000.

The government guarantees 100% of the loan and there won't be any fees or interest to pay for the first 12 months. Loan terms will be up to 6 years. No repayments will be due during the first 12 months. The government will work with lenders to agree a low rate of interest for the remaining period of the loan.

Outset

YTKO's OutSet service has launched a Micro-Business COVID-19 Support programme in Bristol. Reacting to the needs of the business community and Government guidelines, this service will continue to be developed as it is delivered until end of June. Business owners can get in touch with the team to receive an initial telephone call with an expert advisor, followed by training and support on specific topics like furloughing staff; unlocking finance including Government Schemes; content creation; managing change and building resilience and more.

The programme will give *all participants free* access to their GrowSmart e-learning platform. There is a vast bank of resources being constantly updated by their experts which you can work through in your own time around other commitments.

BRAVE Enterprise is one of Bristol's long-established small business advice services. With the help of approachable, experienced business professionals they offer advice, training and consultancy to thousands of people each year – helping them to start and run successful, profitable businesses. Natwest Business Builder

Their Pre-accelerator course has been renamed – now the Business Builder. This is a digital course of learning – currently consisting of 14 modules all focused on building a sustainable business. This is best suited to those at idea stage – or those looking to revisit their foundations, and includes digital learning modules, learning portal, webinars and access to a National thriving Facebook community. Anyone can apply to access this, and it is fully funded by Nat-West. Natwest have an entrepreneurship hub in Bristol which operates the next programme on from this one.

SETsquared

SETsquared Bristol understands that there are complex barriers facing entrepreneurs from non-white backgrounds. This is why SETsquared Bristol partnered with ACH and Up Our Street to execute a piece of research into what the barriers are for Black, Asian and Minority Ethnic (BAME) accessing business incubation in the city. School for Social Entrepreneurs (SSE)

SSE are recruiting for Lloyds Bank Trade Up programme in South Bristol. Applications are open until 30th April and the programme will start in October 2020. It is aimed at small and early stage social enterprises, community businesses, charities and other VCSE organisations, who are looking for support with recovery from the Covid-19 crisis, wish to make their enterprises more resilient and are looking to grow or build back their trading income and potential. They are specifically looking for enterprises from South Bristol to make use of the opportunity and apply to the programme. Participants will receive a match trading grant of up to £4,000, a free action learning programme and mentoring from our Lloyds Bank partners. Princes Trust

Prince's Trust is a charity founded to help vulnerable young people get their lives on track. It supports 11 to 30-year-olds who are unemployed and those struggling at school, and at risk of exclusion. They offer help with s+tarting a business, getting a job and building confidence. This is a government scheme whereby you could get mentoring and an allowance to help you start your own business through New Enterprise Allowance. Watch more here **NEA Campaign Video**

You may be eligible if you're over 18 and either:

- You or your partner get Universal Credit, Jobseeker's Allowance or Employment and Support Allowance
- You get Income Support and you're a lone parent, sick or disabled
- You'll get a mentor who'll give you advice and support to help you set up your business and start to trade.
 Once you've made a business plan that your mentor has approved, you:
- You may get a weekly allowance worth up to £1,274 over 26 weeks
- You can apply for a loan to help with start-up costs

The British Business Bank offers loan to British businesses. These loans are backed by the government. The Coronavirus Business Interruption Loan Scheme (CBILS) is now available.

The scheme consists of over 40 lenders who will be providing up to £5,000,000 in loans through Loans, overdraft, invoice finance and asset finance. There are currently no Sharia compliant loans however we have been advised that they are being considered and may be offered in the future.
